4. First-aid measures

6. Accidental release measures

Methods and materials for containment and cleaning up Large Spills: Dike far ahead of spill for later disposal. Stop the flow of material, if this is without risk. Sweep up or vacuum up spillage and collect in suitable container for disposal. Following product recovery, flush area with water. Put material in suitable, covered, labeled containers.

Small Spills: Vacuum or sweep up material and place in a disposal container. Following product recovery, flush area with water.

Environmental precautions Avoid discharge into drains, water courses or onto the ground.

7. Handling and storage

Precautions for safe handling Obtain special instructions before use. Keep formation of airborne dusts to a minimum. Provide appropriate exhaust ventilation at places where dust is formed. Wear appropriate personal protective equipment. Do not breathe dust. Do not get in eyes, on skin, on clothing. Avoid eating, drinking and smoking when using the product. Observe good industrial hygiene practices. Wash hands thoroughly after handling. Avoid prolonged exposure. Avoid release to the environment.

Conditions for safe storage, including any incompatibilities Store in cool, dry place. Store locked up. Keep container in a well-ventilated place. Store in tightly closed container.
